UTILIZATION OF LABOUR CESS FUNDS

411. SHRI G.C. CHANDRASHEKHAR:

Will the Minister of Labour and Employment be pleased to state:

- (a) the total amount of cess collected for the welfare of labourers since its inception, State- wise;
- (b) the details of the manner in which these funds have been utilized, including specific schemes and projects financed through the collected cess; and
- (c) the new schemes or programs being proposed to be financed through the labour cess in the upcoming fiscal years, the details thereof State-wise and plan year-wise?

ANSWER

MINISTER OF STATE FOR LABOUR AND EMPLOYMENT (SUSHRI SHOBHA KARANDLAJE)

- (a): As per the data received from State/UT Building and Other Construction (BOC) Workers Welfare Boards, the details about the cess, are enclosed as Annexure-I.
- The State Building and Other Construction Workers' Welfare Board are constituted under Section (18) of Building and Other Construction Workers' (Regulation of Employment and Condition of Service) Act, 1996 by the concerned State Government to function under Section (22) of the said Act. The Boards, under Section (24) of the said Act, are empowered to meet expenses on its objects and for purposes authorise by this Act. Ministry of Labour and Employment has also framed a 'Model Welfare Scheme for Building and Other Construction Workers and Action Plan for strengthening Implementation Machinery' for the Boards for its strict compliance. Also, several instructions under Section 60 of the said Act have been issued from time to time to State/UT **BOCW** Welfare Boards for implementation of the provisions of the Act and for optimum utilization of the cess funds. A Monitoring Committee has been constituted to Monitor the implementation of direction issued under Section (60) the said Act, specifically with reference to utilization of cess fund for Welfare Scheme framed by the States/UTs.
