Heard Mr. M. Dutta, learned counsel for the petitioner. Also heard Mr. U. K. Goswami, learned CGC, Mr. M. Islam, learned counsel appearing on behalf of Mr. A.I. Ali, learned standing counsel for the ECI, Mr. G. Sarma, learned standing counsel for the FT Matters, and Mr. P. Sarmah, learned Additional Senior Govt. Advocate for the State.

2. The learned counsel for the petitioner has submitted that pursuant to order dated 09.06.2025, the petitioner has been allowed to meet his father, namely, Abdul Sheikh at the Holding Centre under 7th, APBn., Charaikhola, Kokrajhar.

3. The learned counsel for the petitioner has also submitted that pursuant to order dated 15.04.2020 passed in WP(C) (Suo Motu) 1/ 2020, on completion of 2 (two) years of detention, the father of the petitioner was released on 30.04.2021. He has further submitted that a specific statement was made in paragraph-13 of the writ petition that as per the conditions imposed in the released order, the father of the petitioner has been appearing before the Kajalgaon Police Station every week and his last appearance before the said



Police Station was on 21.05.2025.

4. Accordingly, it is further submitted that as the father of the petitioner is complying with the conditions of bail, he is pressing the prayer for bail.

5. In view of the specific averment made by the petitioner that his father has been attending the Kajalgaon Police Station every week in terms of the order of bail, the Court is inclined to direct the learned Standing Counsel for the FT matters to send a downloaded copy of this order to the Superintendent of Police (Border), Chirang to inform the Court as to whether the father of the petitioner, namely, Abdul Sheikh was detained by the Kajalgaon Police Station on 25.05.2025, had been regularly appearing before the Kajalgaon Police Station every week pursuant to his released on 30.04.2021, for which the learned counsel for the petitioner relies on the Annexure-6 of the writ petition.
