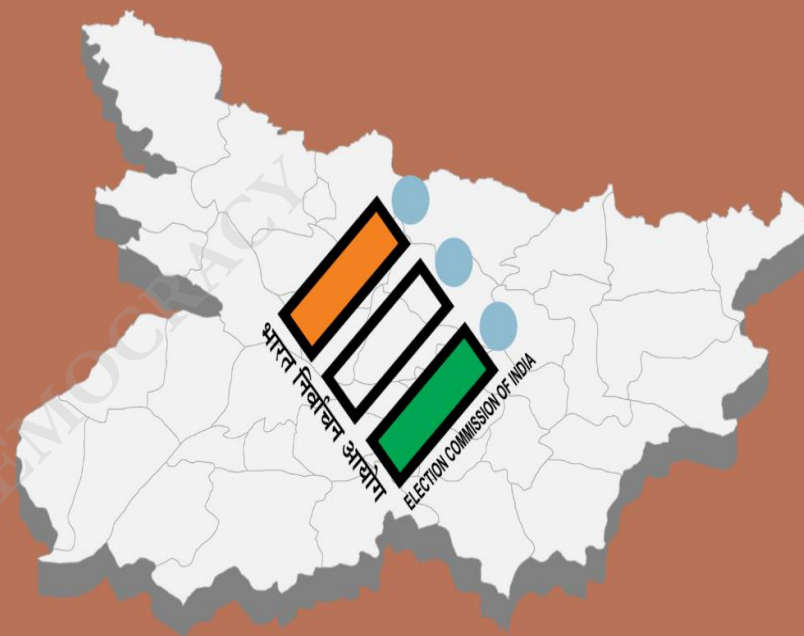

ECI Runs an ‘SIR’ — A Process That **Doesn’t Exist in Law**

Special Intensive Revision (SIR) has **no statutory basis** under Registration of Electors Rules, 1960

2,11,462 ‘Dead’ in over one day

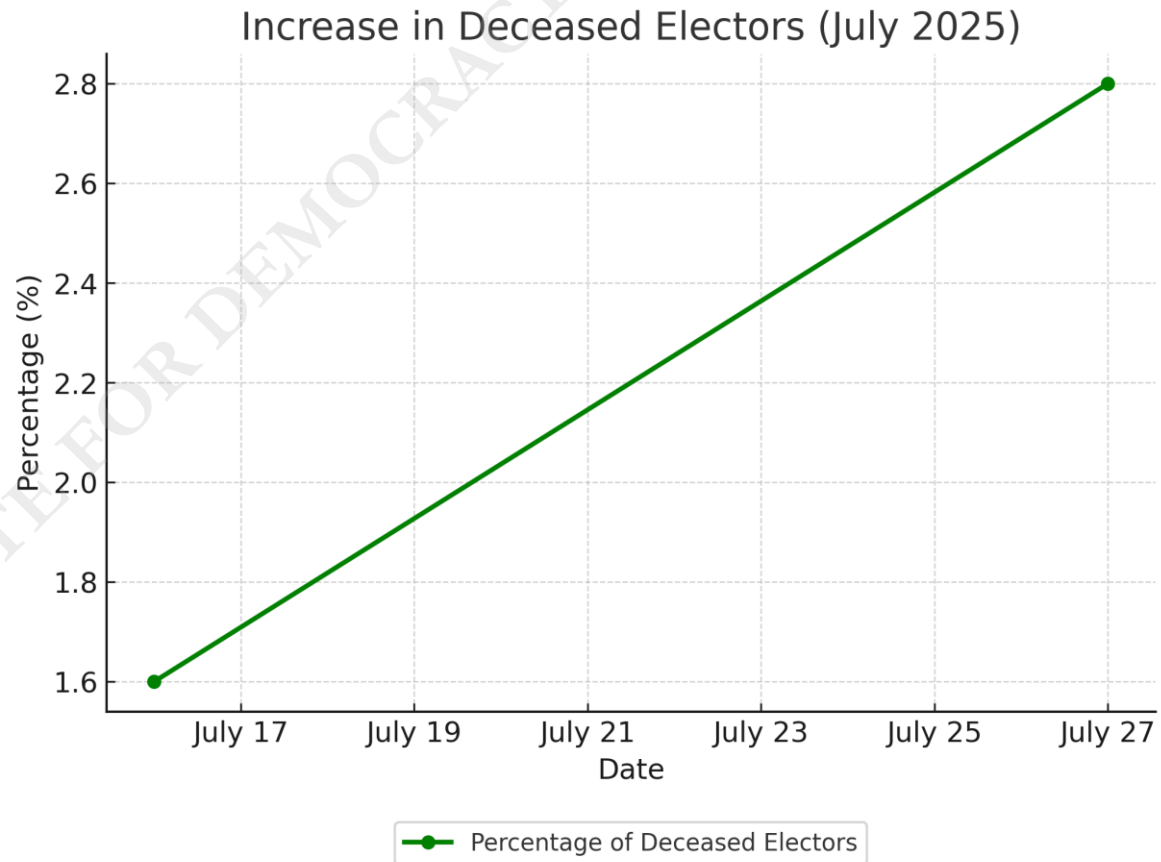
— How?

Unprecedented spike:

- Over just over one day (July 21–22): + **2,11,462** “deceased” voters
- Per constituency: **870** on average removed over one day

Five-day “deceased” surge:

- Dead electors rose from **16,55,407** (July 21) to **22 lakh** (July 25)
- + **5,44,593** in 5 days — 2,241 per constituency



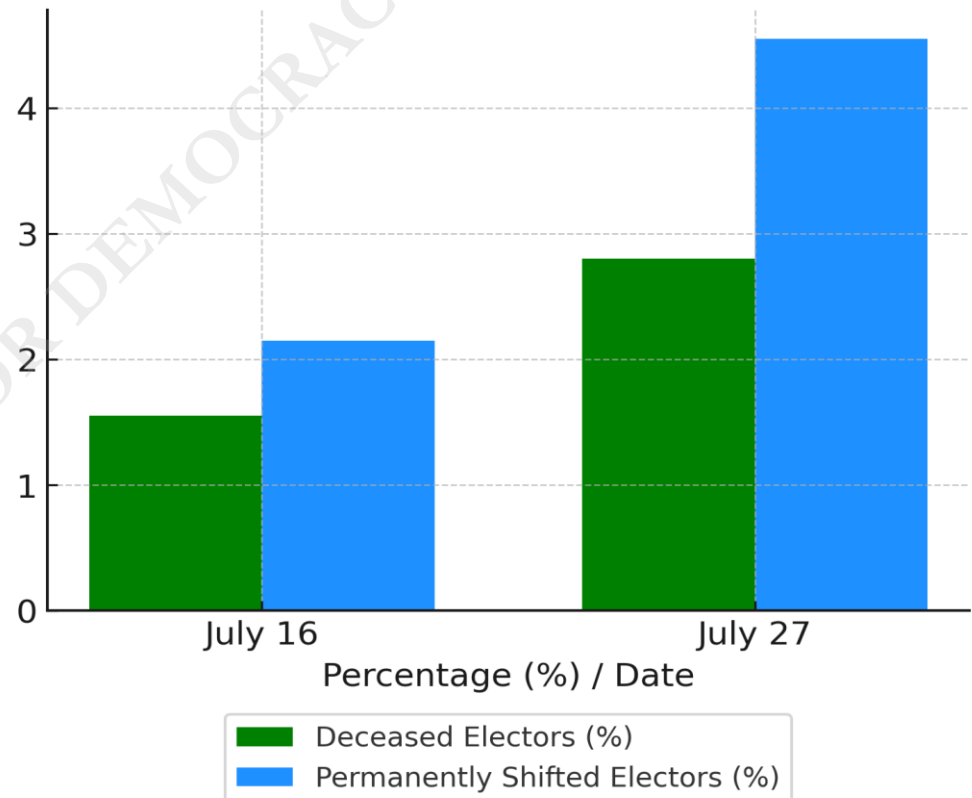
15 Lakh 'Permanently Shifted' in 3 Days

- July 23–25: + **15,24,769** permanently shifted voters (6,275 per constituency)
- Peak: **8,516** removals per constituency in just **3 days**

Deletions exceed forms processed:

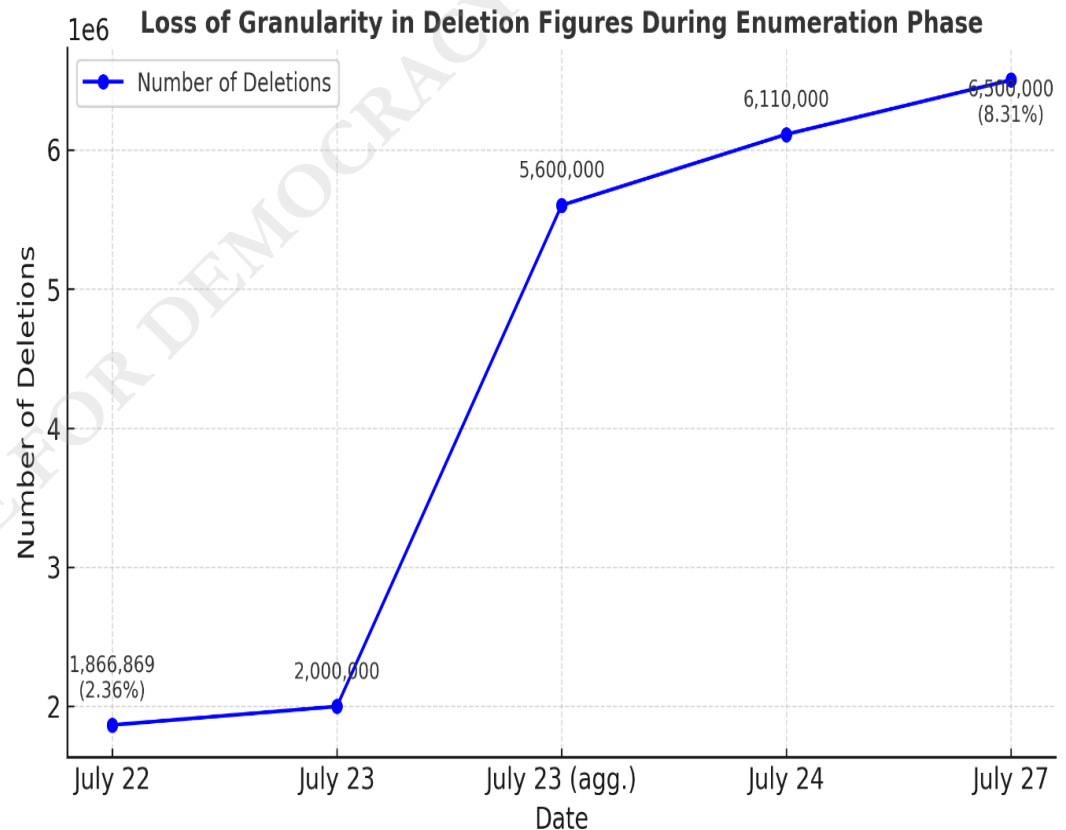
- July 23–25: Digitised electors increase by **6 lakh**, but deceased + permanently shifted increase by **9 lakh**

Elector Changes (July 2025)



Category Disappearance & Data “Jugglery”

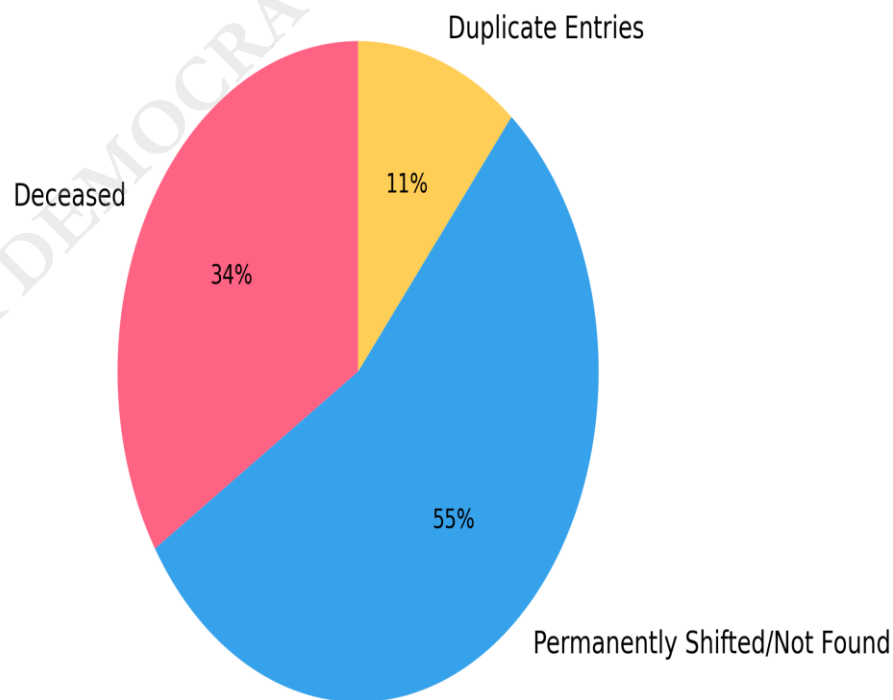
- ‘Multiple registration’ cases drop to **zero** between July 23–25
- Introduced opaque “**Merged Data**” → “Electors not found at their addresses”
- Change **coincided** with sharp deletion surge



Some Districts **Lost More Than 15%** of Their Voters

- **Deletion rates above state average** (8.31% deletions): Gopalganj 15.10%, Purnia 12.08%, Kishanganj 11.82%, Madhubani 10.44%
- Many affected districts have marginalised, migrant, minority populations
- Risk of **targeted disenfranchisement**

Reasons for Deletion of 65 Lakh Voters (8.31% of 7,89,69,844 Total Electorate) in Bihar's SIR (2025)



What About **Natural Justice**?

The Registration of Electors Rules, 1960 recognises only:

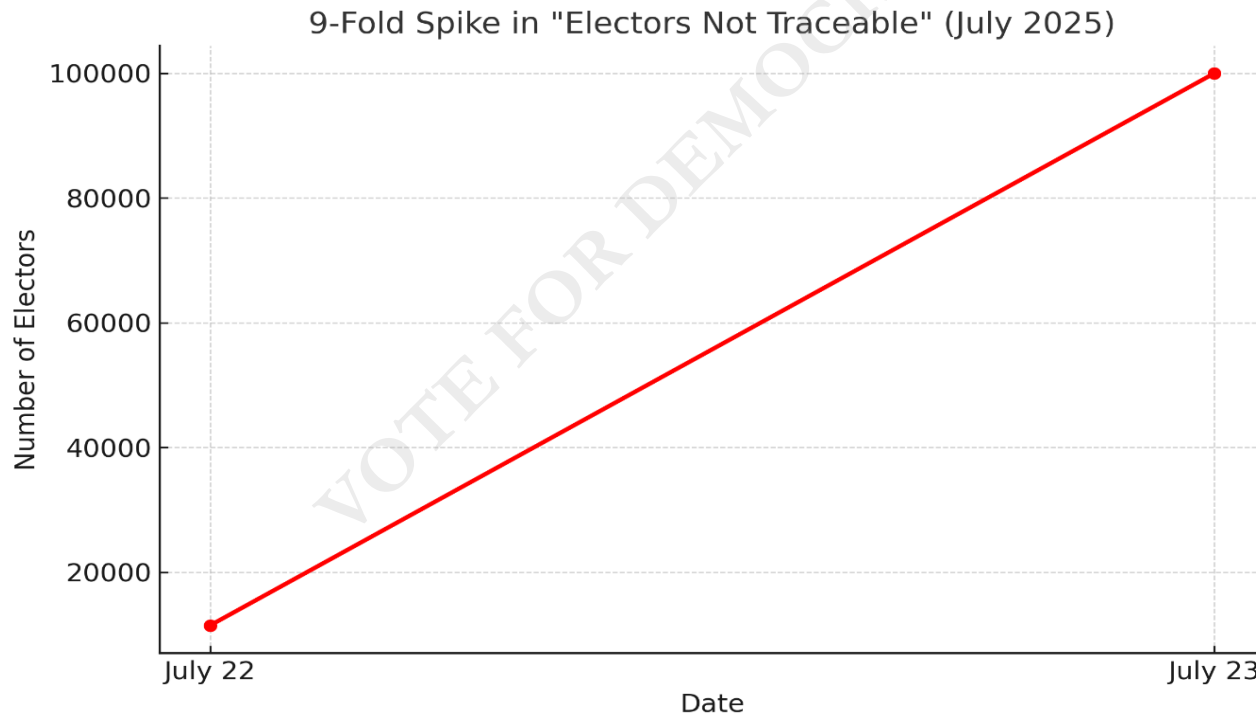
- Summary revision
- Intensive revision
- Partial revision

Rule 8 violation:

- Non-standard enumeration forms used
- No receipts/duplicate copies given to electors
- SC (July 29): no stay on draft rolls, but **warned against “mass exclusion”**
- 65 lakh deletions = Impossible hearing volume: 26,748 per constituency in 1 month
- **Names of deleted voters not published** → no chance for objections
- **Burden shifted to voters to prove inclusion** — reversal of ECI duty

Why It's **Alarming**

- Untraceable” & “permanently shifted” prone to misuse
- Statistical spikes suggest numerical deletion targets
- Supreme Court warning: ‘Mass exclusion will invite intervention’



Transparency Now — Before Democracy is Compromised

VFD demands:

- Publish full list of deleted voters with reasons
- Release documentary proof for each deletion
- Provide constituency-wise breakdown of deletion categories

Credibility of Bihar's voter rolls now rests on judicial scrutiny & transparency
