following
O R D E R

IA No. 209213/2025 in CrI.A. No. 3048/2023:

Inasmuch as the applicant - Mahesh Sitaram Raut is seeking interim bail on medical ground, coupled with the fact that he was actually granted bail by the High Court, against which the Special Leave Petition has been filed by the NIA, we are inclined to grant medical bail, for a period of six weeks, from the date on which the conditions are imposed by the concerned Trial Court.

Accordingly, the applicant - Mahesh Sitaram Raut is granted interim bail for a period of six weeks, as aforementioned, subject to the terms and conditions

that can be imposed by the Trial Court.

We make it clear that after the expiry of the said period, the applicant shall report back to prison.

The application is accordingly allowed.

Though, only the application for interim bail has been listed today for hearing, in view of the plea made by the learned counsel appearing for the accused in both the appeals, we are inclined to list the matters in the month of October, 2025.
