UPON hearing the counsel the Court made the following  
O R D E R

1. The learned counsel appearing for the petitioners has filed an application (I.A. No.30757 of 2026) seeking for direction to the jail authorities to ensure immediate medical examination of the detenuer by a qualified doctor; to direct appropriate diagnostic tests, including tests relating to his stomach ailment, be conducted and necessary treatment be provided without delay; and, to direct the jail authorities to furnish weekly medical reports concerning the detenuer's health condition to the detenuer himself and as well as to petitioner no.1.

2. Mr. K.M. Nataraj, learned Additional Solicitor General for the respondents has placed on record the medical report of the detenuer which would reflect that from 26.09.2025 till 27.01.2026, the detenuer has been medically examined 21 times. The medical examination report of 27.01.2026 would clearly indicate that the blood pressure, SPO<sub>2</sub> level of the detenuer is well within the parameters and is a normal parameter and even the clinical examination of the detenuer relating to chest and abdomen results indicate Clean B/L NAD and Soft NAD. It has also been certified

that General Condition-GC is good. On query made to the detenu by the examining doctor, the detenu has complained about stool frequency and defecation.

3. In this background, the learned Additional Solicitor General would submit that if any medical treatment is required to be extended or warranted, it would be immediately furnished/attended to. He would also assure the Court that detenu would be examined by a specialist from the Government Hospital and a report in this regard would be filed in a sealed cover on or before 02.02.2026. His submission is placed on record.

4. Accordingly, I.A. No.30757 of 2026 stands disposed of.
